THE DEBATE Formats

- 20 minutes - **convenor** introduces the motion and the speakers, then **takes a vote** for and against the motion from the floor
- 6 minutes - **proposer** speaks for the motion
- 6 minutes - **opposer** speaks against the motion
- 4 minutes - second **proposer** speaks for the motion
- 4 minutes - second **opposer** speaks against the motion
- 4 minutes - third **proposer** speaks for the motion
- 4 minutes - third **opposer** speaks against the motion
- 15 minutes - **Audience team** speaks
- 15 minutes - convenor invites **members of the audience** to speak for or against the motion for a maximum of 1 minutes each
- 1 minute – **proposer** (summary)
- 1 minute – **opposer** (summary)
- 10 minutes - **convenor takes a second vote** from the floor to find out if the audience's opinion has been changed.
